1 (Charges called at 1 hour, 50 minutes into  
2 stream. Appearances noted. Defendant is streaming on Twitch,  
3 counsel for Plaintiff present in stream chat.)

4 **OPENING ARGUMENTS BY DEFENDANT**

5 MS. EVERGREEN: Can I give you a little bit of -- can I  
6 ask Chat, John and Stov? Can I ask Chat about it?

7 So, let me show you something, Chat. Here are the  
8 rules.

9 (Defendant's Exhibit #1, a Notepad document  
10 with the rules for the Girly Girl Month, is admitted into  
11 evidence.)

12 Here they are. Now, one of these rules, I technically  
13 violated. Right? Now, all of the hard ones, I have been doing.  
14 I've been going for. I appreciate that I am good at -- anyway,  
15 so here's what has happened. Here's what I did.

16 All of these rules, checked off. Checked stockings,  
17 underwear, makeup every day, eyelash extensions, done.  
18 Earrings, setting that up, doing that. Photos, done. Girl  
19 clothing all the time, Instagram stories, fucking been gaining  
20 on that, dude. Insane for Instagram stories. 100 percent girl's  
21 clothing, hell yeah. Long hair, of course. I don't know why I  
22 even have it. Piercing, same thing, I don't know why I've  
23 written that twice. Jewelry, well, cat ears. Nails done, done.  
24 Only high heels, done. Ten streams, I'm on track to do even  
25 more. Okay. But yeah, I figured I'd stream the toe nails thing,

1 but I figured I've got other things, but yeah. I'll paint my  
2 toes on stream.

3 Use "she/her" pronouns. Now, have I been? Yes.  
4 However, while I was mid-story, while I was talking about like,  
5 how to do makeup and why I like the things I like, I said, "as  
6 a straight guy," while mid-story.

7 Now, that is exactly what happened. I didn't think  
8 about it; I didn't even notice it. Wasn't thinking about it.  
9 Now, should that be treated -- should my bimbo brain -- I think  
10 I was playing into the part, the dumb airhead brain -- should  
11 that be treated as lost the bet? Should it be?

12 MR. KEIWO: See, chat? We told you this would happen.

13 MS. EVERGREEN: Told you what would happen? I guarantee  
14 the poll's gonna be fucking rigged.

15 Who should lose slash who should win the bet? Was I  
16 in the wrong? Yes. Is it -- does it defeat me doing all --  
17 "that's not a pronoun" -- that's a very good point. That's a  
18 very good point, random chatter. It's not a pronoun, hmm? I say  
19 the bet continues. We got another -- we've got another three  
20 weeks of Girl Month, and Girly Girl Month -- Bimbo Month --  
21 we've got another three weeks. I didn't use the wrong pronouns.

22 MR. KEIWO: You said "he."

23 MS. EVERGREEN: How would I refer to myself saying "he?"  
24 How is that possible? What sentence did I say where I would  
25 have said "he?"

1 "You did." How? What did I say?

2 "Get the clips." I don't know what I would have said  
3 to do it.

4 "You didn't even use a pronoun."

5 "You don't even know what a pronoun is, you git."

6 What do you mean? I'm confused. What did I say? What did I say?

7 Summon the evidence. I want to go through this.

8 There's gonna be a court case.

9 "You talked in third person." When? I want to see the  
10 evidence. I want to see the evidence of this. Even though I may  
11 have, it depends on the time period. If I was gonna say like,  
12 fuckin, when I was in high school or something, and I refer to  
13 myself as "he," that makes perfect sense, doesn't it? That  
14 wasn't part of the month. That was back in whenever the fuck. I  
15 wanna see the evidence.

16 DONATION MESSAGE: But you'll be using "she/her" with  
17 the estate agent, right?

18 MS. EVERGREEN: Did the first time, will the second  
19 time, motherfucker. Also, we barely saw each other. They just  
20 kinda let me into the house and I walked around, and then I  
21 said "bye." It was an awkward estate agent trip. Usually an  
22 estate agent shows you around, they just kinda let me in.

23 MR. KEIWO: You said "he," and also should have started  
24 the month with the conditions already met, so it includes ears  
25 pierced and toes.

1 MS. EVERGREEN: Okay, so in your mind, you would have  
2 wanted me to not go to the ear piercing thing dressed as a  
3 girl? You would have rather that I got it done beforehand? That  
4 feels like that would be cheating a bit. I wouldn't do that to  
5 you.

6 "We were fine with that." Well, exactly, that's what  
7 I mean. John brought it up. Interesting.

8 "They didn't believe you could buy the house." True.  
9 I wanna see the evidence of this thing.

10 MR. KEIWO: You cheat all the time.

11 MS. EVERGREEN: How? I've met every rule. I've met every  
12 rule. I'd say that there are three weeks left of this and me  
13 saying -- I wanna see the clip. I really wanna see the clip. I  
14 really wanna know what the clip was, of when I referred to  
15 myself as "he," which I would never do.

16 MR. KEIWO: It's okay, Finn.

17 MS. EVERGREEN: No, this thing's still on, buddy.  
18 There's three weeks left of this. I'm saying if anyone's got  
19 the clips.

20 "Chat, there are more days Rose could lose the bet."  
21 Yeah, another three weeks and a bit.

22 "You'll have to file an FOIA request." Good lord.

23 MR. KEIWO: You want me to go back through an entire VOD  
24 for this petty shit?

25 MS. EVERGREEN: Yes, because it's gonna --

1 MR. KEIWO: This bet is so fucking dumb.

2 MS. EVERGREEN: John? John doesn't wanna shave his legs.  
3 And yes, I do want that. I wanna know, and then we can vote on  
4 it. I'll set up a court case for it. I'll go on Google Images,  
5 find a good court setting, we'll host a whole court. We'll pick  
6 some judges too. Look.

7 All right. I'm getting my -- I'm getting this all set  
8 up. I'll go through it with you guys, okay?

9 "Courtroom." There we go.

10 MR. KEIWO: I already have no hair on my legs.

11 MS. EVERGREEN: Don't care.

12 "Have Kyle as a judge." (Laughing) Okay. Let's see.  
13 I'll add myself an image texture, a source, bam, call it --  
14 "Add Source" -- "Courtroom." Here we go. Here we go. The  
15 courtroom.

16 (An image of a courtroom scene is added to  
17 the stream graphics.)

18 It's perfect. It is so perfect. Okay.

19 I should probably have added this into my recording  
20 layer, actually. So let me do it here instead. Hold on. Image,  
21 add -- court -- there we go. Okay. So then now I can like, move  
22 my camera around and shit. Okay. Let me put it below there,  
23 okay. Perfect. I'm in the defender's seat, over here. No, here.  
24 Those two people there are you. Perfect.

25 (Case called at 1 hour, 58 minutes.)

1 All right. I wanna know the clip in question, all  
2 right? I'll pull it up on the screen, I'll get a Twitch clip  
3 link thing going. Hold on. Go to Channel -- let's see what I  
4 can find. Okay. Videos -- and, clips -- "get Riza to be the  
5 judge" -- (Laughing).

6 Oh my god, the fuckin -- the clip of me with the  
7 "Oops" thing has 125 thousand views. Jesus Christ.

8 Why is that like, not doing that? Okay, fuck it.  
9 Okay.

10 MR. STOVAMOR: That isn't a UK court. You have no  
11 jurisdiction over me.

12 MS. EVERGREEN: Yes, I do.

13 Have we found the clip yet? I wonder if we can  
14 actually find where it happened. Hmm. I'm not sure. "This is a  
15 prison --" (Laughing).

16 Okay. I wanna find where it happened. I wanna  
17 actually go through and review it. This means a lot to me.  
18 Let's see. I wanna see clips -- Reddit? Have you found it?  
19 Comments. "He." Oh. Okay. I found it. It's on Reddit. I have  
20 not reviewed this yet, all right? Let me open it in a new tab.  
21 I haven't even seen this clip. Okay?

22 I'm gonna go onto my recording, I'm gonna add a  
23 display capture real quick. Okay. Add that, here's the clip.  
24 Let's move it into place. All right. The evidence.

25 (Plaintiff's Exhibit #1, a video clip of Ms.

1 Evergreen from the April 17, 2022 stream, has been admitted  
2 into evidence.)

3 The evidence on trial, okay? Ready? Let's see.  
4 Volume's all the way on. Let's do it. What did I say?

5 (Plaintiff's Exhibit #1 is played back on  
6 stream.)

#### 7 EXHIBIT PLAYBACK

8 MS. EVERGREEN: Dudes can't tell that I'm  
9 wearing makeup at all. It's fucking crazy. I do need  
10 to wear like, bright -- I could be doing -- I could  
11 have this, but if you take away some lip gloss, guys  
12 could say like -- "he's not wearing any makeup."

13 Dude. I'm wearing pounds, bro. I'm wearing a  
14 little bit of makeup right now.

#### 15 ARGUMENTS BY DEFENDANT

16 MS. EVERGREEN: Hmm. Interesting, okay. So, "guys could  
17 say, he's not wearing any makeup." That's the exact quote.  
18 "Guys could say he's not wearing any makeup." Court -- can we  
19 get that -- who's the person, stenographer? Can we get that  
20 written down. So, as the defense, am I allowed to --

21 The jury -- I'm also the judge --

22 THE COURT: The jury is very loud right now. Silence in  
23 my courtroom. Silence in my courtroom. Silence. Okay.

24 MS. EVERGREEN: I wanna make it clear that the defendant  
25 is quoting something else, is quoting what others may view the

1 defendant as, rather than the defendant talking about himself.

2 I -- this was not even in the third person, this was  
3 in the second person. A view that -- a view that -- a view from  
4 someone other than the defendant -- I would make my case -- I'm  
5 arguing for a not guilty plea. I'll take a not guilty plea.

6 Could I hear from -- hold on -- can I get a -- Stov,  
7 can I get in like a Discord call or something? I wanna get in a  
8 Discord call and I wanna hear your arguments against John and  
9 Stov. I'm gonna join the general chat in the Council chat -- if  
10 you'd like to join, you can join. I'll let you present your  
11 case. I'm in the Discord chat. I'm in the room, I want you to  
12 present your case to me.

13 (Ms. Evergreen entered Discord chat.)

14 Let me review this clip again, so I can show you.

15 (Plaintiff's Exhibit #1 is played back a  
16 second time on stream.)

17 **EXHIBIT PLAYBACK**

18 MS. EVERGREEN: Dudes can't tell that I'm  
19 wearing makeup at all. It's fucking crazy.

20 DONATION MESSAGE: You said "himself" just now, ma'am.

21 MS. EVERGREEN: I do need to wear like,  
22 bright -- I could be doing -- I could have this, but  
23 if you take away some lip gloss, guys could say like  
24 -- "he's not wearing any makeup."

25 MS. EVERGREEN: "Guys could say."

1 DONATION MESSAGE: After review, we'll choose to let Rose  
2 do the honorable thing.

3 (Counsel for Plaintiff entered Discord  
4 chat.)

5 MS. EVERGREEN: Oh, hey, guys. Hello.

6 MR. STOVAMOR: Hello.

7 MS. EVERGREEN: Hey.

8 **CROSS EXAMINATION OF MR. STOVAMOR**

9 **BY MS. EVERGREEN:**

10 **Q.** You've seen the clip. What would you -- what could  
11 possibly be your defense? Your -- I don't know what the  
12 other party's called.

13 **A.** In your statement to the jury, you screwed up more than  
14 you did on that clip.

15 MR. KEIWO: Yeah.

16 MS. EVERGREEN: I'm cosplaying as the defendant right  
17 now. I'm in character.

18 I just wanna play the clip again, just so the jury is  
19 aware. Hold on, I'm gonna play the clip again, so the jury is  
20 aware of the exact scenario, okay?

21 (Plaintiff's Exhibit #1 is played back a  
22 third time on stream.)

23 **EXHIBIT PLAYBACK**

24 MS. EVERGREEN: Dudes can't tell that I'm  
25 wearing makeup at all.

1 MR. STOVAMOR: It's a scam.

2 MS. EVERGREEN: It's fucking crazy. I do  
3 need to wear like, bright -- I could be doing -- I  
4 could have this, but if you take away some lip gloss,  
5 guys could say like -- "he's not wearing any makeup."

6 Dude. I'm wearing pounds.

7 MS. EVERGREEN: I think that it was very, very clear  
8 from the clip in question that I am quoting someone else.

9 DONATION MESSAGE: Your stream is turning into a drama  
10 about a single female lawyer. This is what I wanted all along,  
11 it turns out.

12 MR. KEIWO: If it makes you feel better.

13 **CONTINUED CROSS EXAMINATION OF MR. STOVAMOR**

14 **BY MS. EVERGREEN:**

15 **Q.** Now, as I am the judge and defendant at the same time,  
16 while I was talking about the defendant, I may have also  
17 done an oopsie.

18 **A.** Yeah. You did.

19 MR. KEIWO: Mm-hmm.

20 **Q.** But is that worthy of a guilty sentence?

21 MR. KEIWO: Yes.

22 MS. EVERGREEN: I would argue not.

23 Chat jury?

24 MR. STOVAMOR: Chat has no chill about this at all.

25 MR. KEIWO: No. I just wanna be done with it. I think

1 it's pointless, because we knew from the get-go that you  
2 wouldn't be able to do it, and like, I don't hold it against  
3 you, and it's not a thing of, "I'm not mad, I'm disappointed,"  
4 it's not even that, it's just -- it's not gonna work.

5 MS. EVERGREEN: I'd like to make a counter-argument.

6 John is French, and they can't be trusted.

7 MR. STOVAMOR: Look, we're all friends now, okay?

8 THE COURT: I don't like these ad hominem attacks.

9 MR. KEIWO: I'm not -- I'm not a friend.

10 MR. STOVAMOR: I'm talking about Birmingham and Bristol,  
11 not France, obviously, but you know.

12 THE COURT: I don't know about you guys, but -- order.  
13 Order. Things slip. French panic. It's a valid defense.

14 MS. EVERGREEN: Listen, I personally, as the defendant,  
15 feel like while the crime may have been committed in this here  
16 courtroom, I may add -- I'm very sorry -- in fact, let me add a  
17 display capture for you guys. I don't wanna have you guys --  
18 let me add a display capture for you guys, for the Discord  
19 call.

20 There you go. Okay. Let me move this over here. Just  
21 -- uno momento. Hold on. I wanna sit you guys in the other  
22 seat.

23 MR. KEIWO: Oh god.

24 MR. STOVAMOR: Oh god.

25 THE COURT: I want this -- I will not have this be a

1 kangaroo court. This will be a real court case with the  
2 defendant's plea, and the accusers are wrong. Okay. Let's move  
3 you there. Okay.

4 MR. STOVAMOR: I will note that I was actually AFK when  
5 all of this started, so -- if you have anything.

6 MS. EVERGREEN: The accuser wasn't even an eyewitness.  
7 There are very few eyewitnesses to this crime. Very few.

8 MR. KEIWO: I was there. I was there. I was the one who  
9 called it.

10 **CROSS EXAMINATION OF MR. KEIWO**

11 **BY MS. EVERGREEN:**

12 **Q.** How can we trust you? How can we trust you? How are you  
13 a valid witness?

14 **A.** Have I ever lied to you?

15 MR. STOVAMOR: Also, you did just leak Council chat with  
16 Amoya being really sus. So, you know.

17 MR. KEIWO: Yeah, dude.

18 MS. EVERGREEN: It's okay.

19 **A.** But yeah, like, okay. Let's ask the main people that  
20 will vote on it: Chat.

21 MS. EVERGREEN: John is a known user of 4chan. He cannot  
22 be trusted.

23 I just wanna get everything on the table.

24 MR. STOVAMOR: John monitors 4chan.

25 **A.** That is so fucking low to use. I will not take this kind

1 of slander upon my person. Chat, I ask you -- I am asking  
2 you for your financial support.

3 **Q.** Is John a valid -- could this man be trusted as a valid  
4 witness?

5 **A.** Yes.

6 **Q.** I say no.

7 **A.** And if you don't, that's racist.

8 **ARGUMENTS ON BEHALF OF PLAINTIFF**

9 **MR. STOVAMOR:** This is defamation of character. It's  
10 obviously defamation of character, and yeah, we could sue.

11 **MS. EVERGREEN:** I think it's misogynistic. A pretty  
12 woman, versus you guys, I'm just saying. I think it could be  
13 misogyny. A known 4chan user, misogyny, you know, links a  
14 little bit, maybe? I'm not saying anything. Just saying that  
15 maybe it's something the jury should think about heavily.

16 **MR. KEIWO:** Okay, I wanna ask something to Chat. Chat,  
17 do you think that the heels rule should be that every stream he  
18 has to wear the heels?

19 **MS. EVERGREEN:** Every stream heels rule?

20 **MR. KEIWO:** And does he have to wear the heels from the  
21 moment he starts the stream 'til the end?

22 **MS. EVERGREEN:** On the original rules, I'd say no.

23 **MR. KEIWO:** Because if the rule is to have heels, then I  
24 believe that since there is no time specified, you can just  
25 say, "I'm gonna give myself the liberty to put them on for five

1 minutes at the end of the stream, so I can say I've worn the  
2 heels."

3 **CONTINUED CROSS EXAMINATION OF MR. KEIWO**

4 **BY MS. EVERGREEN:**

5 **Q.** I have more evidence to call for this exact point.

6 (Defendant's Exhibit #2, a Notepad document  
7 with the rules for Girl Months, is admitted into evidence.)

8 I do have the original rules sheet written up here.  
9 "Only high heeled shoes allowed." Right?

10 **A.** Yeah.

11 **Q.** This is a reference. You'd say -- I know there is a  
12 language barrier -- again, French, may I remind the court.

13 **A.** I un --

14 **Q.** I'm speaking.

15 So, this does refer -- this does imply that only high  
16 heeled shoes will be allowed. In the context of needing  
17 shoes -- I have not worn a single non-heeled shoe  
18 throughout this entire -- not even throughout these  
19 proceedings -- throughout my last five days.

20 **A.** But you have not worn the shoes when streaming. You have  
21 not worn the shoes at the moments you were streaming, which  
22 are the only moments that Chat can verify that you are  
23 actually doing the rule. How can they believe that you are  
24 applying the rules correctly in your off time off-stream,  
25 if they don't even see you doing it on live stream when

1       you're supposed to do it?

2           THE COURT: These are personal ad hominem attacks that  
3 are not relevant to the current proceedings.

4           MR. KEIWO: See? See, Chat?

5           THE COURT: We're arguing the case of the pro -- the  
6 case of the pronouns.

7 **A.**       You know, this reminds me of a sketch from Kevin Hart  
8 where his mother is supposed to beat the shit out of him,  
9 and she's telling him, "don't do the things I told you to  
10 do the way you want to do it; do the things I told you to  
11 do the way I wanted you to do it when I pictured you doing  
12 it."

13           Chat has a picture in mind of what you were supposed  
14 to do, and you were supposed to be clear on it, you know?  
15 And you did -- what you wanted to do.

16 **Q.**       Wait, hold on. I do have a defense for this. I would  
17 argue that I have been showing you what shoes I've been  
18 wearing.

19           In my very first Instagram story, may I add, I did  
20 actually take that time to show my shoes. It's not  
21 something I frequently show, but since you wanted to bring  
22 it up that -- let the defense finish -- that I did in fact  
23 wear those, and I did actually show that to Chat.

24 **A.**       This one is right. But nothing else. So it's still a  
25 violation. You can't say, "I did it that one time, so if I

1 don't do it all the time, it's okay."

2 MR. STOVAMOR: As the saying goes, "even a stopped clock  
3 is right twice a day."

4 Q. But I would like you to think about that -- in the  
5 amount of times that you have been presented evidence of me  
6 wearing shoes, and the amount of times you've been  
7 presented evidence that I have not, one is equal to 1, one  
8 is equal to 0.

9 A. Yeah, but the thing is, we only need that one time that  
10 you didn't wear them to consider that you've lost.

11 Q. Do you have any evidence whatsoever that I've worn  
12 non-heeled shoes?

13 A. Well, today?

14 Q. No. That I have worn non-heeled shoes? When? Do you have  
15 evidence that I have worn non-heeled shoes?

16 A. Right now? Do you have heels on your feet?

17 Q. I do.

18 A. Did you have them at the beginning of the stream?

19 Q. Was I wearing non-heeled shoes at the beginning of the  
20 stream? No, I was not.

21 A. You were not wearing shoes at all.

22 Q. That's a very different thing to non-heeled shoes.

23 Let me present my case to the court. Sorry -- let me  
24 present my case to the jury.

25 A. Like I'm saying to Chat, see?

1 Q. Speculation. That is just speculation. You have no  
2 evidence that I have ever worn a non-heeled shoe. Wearing  
3 heels at all was not part of the rules. I will wear either  
4 none or some. You can't expect me to wear -- does the jury  
5 expect me to wear heels to sleep? To --

6 A. No.

7 Q. To my -- in my bathroom? In the shower? Non-heeled shoes  
8 are definitely not allowed; heeled shoes only when the  
9 situation calls for it. I think that is a valid defense.

10 MS. EVERGREEN: The accusers are operating with no  
11 evidence, pure speculation, and I would highly advise the jury  
12 to consider why they are bringing up these points.

13 MR. KEIWO: I'm thinking about this one now --

14 MS. EVERGREEN: These weak points.

15 MR. KEIWO: Like, there has been so many violations.

16 Okay. Should Chat agree with me on this one, that you  
17 should have started with the conditions already met, and then  
18 we can say the conditions are failed because they're not  
19 respected? It's like when you start a job with some basic  
20 package, you should not like, you should consider it failed if  
21 you lose some items of the package, you know? You should have  
22 started the month with the toenails already painted and the  
23 ears pierced.

24 MR. STOVAMOR: Exactly. Here's the thing. You keep  
25 saying, "yeah, I'll the ears re-pierced. Yeah, I'll do that

1 tomorrow. Yeah, tomorrow, I'll go tomorrow. I'll just go in and  
2 get them done." And then you don't.

3 MR. KEIWO: And then you end up doing them on the last  
4 day.

5 MR. STOVAMOR: And then it keeps going and going and  
6 going and going and going.

7 MS. EVERGREEN: Hmm. Are the accusers finished with  
8 their point? I've got a counter-argument.

9 **ARGUMENTS BY DEFENDANT**

10 MS. EVERGREEN: Okay. I would like to query the jury on  
11 this one.

12 Would the jury -- on the accusers, that, by the way,  
13 do benefit directly from me losing this court case, just an FYI  
14 -- would you like to go with the accusers' dream world, their  
15 -- what their goal is -- for me to have got my ear piercings  
16 done dressed like a grubby man, with no hot and sexy clothes or  
17 makeup on at all? No fake eyelashes, no fake nails, no skirt,  
18 no heels, no nothing, go get my eyelashes done, just like that?

19 MR. STOVAMOR: Counterpoint --

20 MS. EVERGREEN: Go get my nails done, my ears pierced,  
21 just like that?

22 MR. STOVAMOR: Counterpoint --

23 MS. EVERGREEN: Hold on, I let the accused finish.

24 MR. STOVAMOR: Counterpoint.

25 MS. EVERGREEN: You would let me finish.

1 Or, have my nails done off camera with no stream  
2 content to get from it at all? The nail painting professionals  
3 of the Chat would never see that at all.

4 MR. STOVAMOR: So you did get your nails painted off  
5 camera, off stream.

6 MS. EVERGREEN: I get my -- I didn't get my toes --

7 MR. STOVAMOR: You have got your ears pierced off  
8 stream.

9 MS. EVERGREEN: That was months ago.

10 MR. STOVAMOR: You got your eyelashes done off stream,  
11 so saying that you're gonna do this for stream content is  
12 complete and utter hogwash.

13 MS. EVERGREEN: Listen. The nails were done far before  
14 Bimbo Month started, the eyelashes were due to be done and then  
15 they got COVID. My accused have no respect for the COVID virus.

16 "Hogwash." (Laughing)

17 The accused --

18 MR. STOVAMOR: Well, Chat, I didn't want to swear,  
19 because obviously, you know, I'm a deeply kind and sensitive  
20 person and I wouldn't want to --

21 MR. KEIWO: (Laughing)

22 MR. STOVAMOR: Wouldn't want to use the F word, or --

23 MS. EVERGREEN: Even the accusers are laughing at this  
24 point. This -- I don't know.

25 MR. KEIWO: Honesty makes me laugh. This is why I always

1 laugh my ass off when I'm watching you stream. I always laugh  
2 because you're so honest with us.

3 MS. EVERGREEN: Yeah, honesty makes you laugh, huh?  
4 That's an interesting point. That's a -- very, very  
5 interesting.

6 MR. STOVAMOR: Did you not see the double quotes around  
7 the word "honesty" in John's statement just then?

8 MS. EVERGREEN: I did not. I did not see it. He spoke.  
9 The accusers cannot even distinguish written language from  
10 spoken. I rest my case.

11 MR. STOVAMOR: Says the dyslexic. (Laughing)

12 MR. KEIWO: (Laughing)

13 MS. EVERGREEN: (Laughing)

14 THE COURT: Ad hominem attacks. Ad hominem attacks.  
15 Irrelevant to the case at all.

16 Okay. I feel like we should go for closing statements  
17 at this point. Would you like to present your closing  
18 arguments?

19 **CLOSING ARGUMENTS ON BEHALF OF PLAINTIFF**

20 MR. KEIWO: My closing argument is, you have made  
21 several violations that you do not recognize as such.

22 MS. EVERGREEN: (Shaking her head).

23 MR. KEIWO: We won't hold it against you; personally, I  
24 do not care with the bet, whether you win or lose, because --  
25 okay. Let's say you win.

1 MS. EVERGREEN: I heard no laughing under that  
2 statement. So no -- false. False and a lie.

3 MR. KEIWO: F1NN, I am basically hairless. I do not care  
4 if I have to shave my face, my whole ass, my arms and my legs.  
5 I do not care. I don't have any hair on my body already.

6 Stov can grow back his beard in less time than it  
7 takes you to grow a fucking pimple. Okay? So, I don't care. And  
8 if you lose, you just have to put clothes in the Box that you  
9 weren't gonna use anymore because you just tried to scam Chat  
10 by saying, "it's not men's clothes, it's unisex. We never said  
11 not unisex." So, whatever's in the Box, you're not gonna use it  
12 anyway. It's stinky, it's rotten, you don't want it.

13 The Box is a fool's fucking promise and a fool's  
14 threat, because the Box is not a real threat. The Box is not a  
15 real threat. Only some weird people in chat think the Box is a  
16 real threat. The Box is not a threat. It's just a game.

17 So that's what -- no one loses anything. No one -- so  
18 I don't know what -- oh, we gained viewers. Okay. We need to  
19 keep going.

20 I don't know why we spend so long -- so our case is,  
21 you lose.

22 **CLOSING ARGUMENTS BY DEFENDANT**

23 MS. EVERGREEN: Okay. Let me present my closing  
24 argument. I've just got a little --

25 MR. KEIWO: Chat, it's not that serious. It's not.

1 MS. EVERGREEN: Okay. Now, listen. Okay.

2 (Some music starts to play.)

3 MR. STOVAMOR: Oh, come on. (Laughing)

4 MR. KEIWO: (Laughing)

5 MS. EVERGREEN: Listen, Chat. I'm muting.

6 (Counsel for Plaintiff have been muted in  
7 the Discord call.)

8 Listen, Chat. This evidence, I would like you to  
9 think about this. Heavily. When a small-time criminal maybe  
10 shoplifts a chocolate bar from a store, what do we do? Do we  
11 send them to jail for decades? Send them to prison for the rest  
12 of their life?

13 Not at all. A small crime should be treated as such.  
14 A small violation of our society's rules? We have never -- we  
15 have never once in the history of humanity had such a violent  
16 repercussion for such a small, small violation. Besides back in  
17 ancient, ancient times, when they burned people alive.

18 Do you want to go back to that level of savagery,  
19 Chat? Because I sure don't. I want to see society progress  
20 along with you. I want the jury to know that this small thing  
21 -- referring to myself in the third person as "he" -- is that  
22 really, is that really worthy of throwing away all that we've  
23 built up over time -- the nails, the eyelashes, the good times,  
24 the D-cup breasts at all times, Chat? The cute outfits? Do you  
25 want that all to be taken away, thrown away, meaningless?

1 I just want you to have a good think about this  
2 before you make your final choice. Your final decision. We'll  
3 make the poll now. I want you to keep my words in mind.

4 **JURY DELIBERATION a.k.a. TWITCH CHAT POLL**

5 THE COURT: Okay. Let's start up the poll. Let's see.  
6 Let's start up the poll.

7 DONATION MESSAGE: I wasn't listening to what she said  
8 but goddamn was it smart. Hashtag I'm with her.

9 MS. EVERGREEN: Vote, Chat. Do it. Do it for all that is  
10 good in the world.

11 This is for justice, Chat. The innocent plea for  
12 justice and peace and prosperity.

13 I will -- I will just say that quite a lot of you are  
14 -- quite a lot of you are voting for guilty. That wasn't --  
15 that wasn't the idea. Just as an FYI, that wasn't what I was  
16 pushing you towards. I was pushing you towards the innocent  
17 vote. Vote innocent if you want freedom and democracy.

18 You want this tyranny, Chat?

19 DONATION MESSAGE: Did she just threaten to not follow  
20 GGM rules if she loses?

21 (Music increases in volume.)

22 MS. EVERGREEN: Nope. I did not. I was saying the  
23 meaning of it would be thrown away. Thrown away, should that be  
24 the case. If a guilty plea is the verdict, think about all  
25 we've done, Chat. All we've done together. Thrown away, like

1 sand to a beach. Meaningless.

2 Tyranny is not the way that I see my community  
3 growing. It's in the face of tyranny that democracy will reign  
4 supreme.

5 I promise to keep this trust going if you will allow  
6 me to, Chat.

7 (Music stops playing.)

8 (A different piece of music starts to play.)

9 DONATION MESSAGE: I love democracy.

10 MS. EVERGREEN: Democracy lost today.

11 DONATION MESSAGE: All right bro, you took the photo for  
12 the thumbnail for the stream and didn't even like the tweet?  
13 Come on now.

14 (Stream goes gray.)

15 MS. EVERGREEN: The plea was guilty.

16 Such dog shit music.

17 I want you to think about what you've done today,  
18 Chat. The jury? You're sending an innocent man --

19 You're sending an innocent girl to -- (Laughing).

20 You're sending an innocent girl to -- (Laughing).

21 (Music increases in volume.)

22 DONATION MESSAGE: Guilty as hell, but I propose we go  
23 for jury nullification.

24 (Music stops playing.)

25 **APPEAL BY DEFENDANT**

1 MS. EVERGREEN: Jury nullification poll? What would --  
2 how could we make that happen?

3 (Stream colors return.)

4 I think that's a good idea.

5 Um, I would like to propose a counter-argument. A  
6 counter-plea. That I look really hot, and I'll go on a date  
7 with each and every one of you if you say that I'm innocent.

8 I'd say innocent. Personally, as a member of the  
9 jury, I'd say -- I'd say vote innocent.

10 DONATION MESSAGE: No.

11 MS. EVERGREEN: Thanks for agreeing with me that the  
12 response to the decision from the rest of Chat would be "no."

13 DONATION MESSAGE: So five more months of Box, yeah?

14 MS. EVERGREEN: I would like to say, this does feel like  
15 a bit of a -- this does feel like a bit of a kangaroo court,  
16 where everyone involved has something to gain. All of the jury  
17 -- "jury nullification is your last chance" -- I would go for a  
18 jury nullification poll, just because the jury had something to  
19 gain from my conviction. Just so you know.

20 As an innocent woman, I have been discriminated  
21 against.

22 "What could we possibly have to gain?" The jury had a  
23 lot to gain. The jury had five months of the Box to gain, so  
24 they had something to gain from it, and I feel like it was an  
25 unfair court case -- an unfair ruling.

1 MR. STOVAMOR: I have an offer, and to be honest, you  
2 fucked your own defense over. It was the equivalent of shouting  
3 out, "I did murder him" in court.

4 MS. EVERGREEN: Hmm. What's the offer? What's the offer?  
5 Stov, what the fuck is the offer?

6 Because a lot of times in court --

7 MR. STOVAMOR: Restart the month.

8 MS. EVERGREEN: That's a shitty fuckin -- that's a  
9 shitty plea deal.

10 DONATION MESSAGE: "This court case is unfair. My  
11 opponents had something to gain from my losing." Huh?

12 MS. EVERGREEN: No, the jury had something to gain from  
13 my losing. That's not what -- the jury is supposed to be a  
14 neutral third party.

15 MR. KEIWO: That's quite fair.

16 MS. EVERGREEN: I feel like restarting the month would  
17 be a bad idea.

18 "One string bikini stream." Good lord.

19 I'd say we -- I'd say we continue the bet going, for the  
20 price of one bikini stream -- one string bikini stream.

21 I would like to know what the jury thinks about that

22 "It's only five days." It's only five days? It feels like  
23 it's been weeks.

24 Okay. Here's what I can do -- here's what I can do,  
25 because scheduling bad, here's what I can do, right. Let me

1 like, close these. Here's what I can do. Let me like, quickly  
2 go and edit some layers out.

3 Okay. Here's what I can do. Let me go onto the Is It Girl  
4 Month calendar. Okay. I'm on -- what the fuck -- hold on. There  
5 we go.

6 I'm on the Is It Girl Month calendar. Here's what I can do  
7 -- five days is a lot of extra fuckin time. Okay. Because I  
8 can't really change this end date, what I can do is add on  
9 another five days at the end of it.

10 MR. STOVAMOR: It's one day more than four.

11 MS. EVERGREEN: That's not make -- I can add on five  
12 days at the end of it, but I can't change the two week by two  
13 week by two week -- I don't know if I'm willing to.

14 I'll think about it.

15 DONATION MESSAGE: I support Rose on the bikini stream.  
16 Though Lady Evergreen is distinctly guilty multiple times over.  
17 And Stov did try to give her all sorts of ways out.

18 MS. EVERGREEN: No, he did not. You're kidding me. No,  
19 he did not. Stov did not try and give me a way out.

20 DONATION MESSAGE: Five days against five months, it's a  
21 no-brainer. Sorry, forgot for you it's Bimbo Month.

22 MS. EVERGREEN: I'll restart the stream, without the --

23 DONATION MESSAGE: One stream, LittleForBig onesie  
24 stream.

25 MS. EVERGREEN: Oh, I'm gonna do that anyway.

1           Hmm. "Standing bikini stream." Holy shit. You're  
2 gonna see one of my balls.

3           DONATION MESSAGE: Now you get to be tried on the  
4 separate counts of saying "himself" and "man."

5           MS. EVERGREEN: I'm thinking. I'm giving it some  
6 thought. Give me a minute.

7           DONATION MESSAGE: Guys, if we're ever getting an OF you  
8 best expect it to be another scam.

9           MS. EVERGREEN: If I start an OF that's gonna make a  
10 fuckton of money, you're not getting scammed, but I'm not gonna  
11 do that. It's a stupid idea.

12          DONATION MESSAGE: I'm not saying you're a scammer and a  
13 cheater and a gremlin and a convicted felon or anything, but  
14 can you explain precisely what a "string bikini stream" would  
15 entail?

16          MS. EVERGREEN: A bikini. But not one of the -- not the  
17 swimsuit thing where it's all covered. Just like, bikini top,  
18 bikini bottoms.

19          DONATION MESSAGE: Just imagine if Finn got called to  
20 stand on a jury during Girl Month.

21          MS. EVERGREEN: Oh my god. I mean, I don't think -- I  
22 don't think that's a thing in the UK. I mean, I've never heard  
23 of that. But I guess.

24                 Okay.

25          MR. STOVAMOR: I'm offering you one "get out of jail

1 free" card. To be honest, I thought you would have messed up  
2 earlier than this.

3 MS. EVERGREEN: I will add one week to it, if the rules  
4 around referring to myself as "she/her" are relaxed as well.  
5 Not saying taken away, but relaxed.

6 I think we should do a poll. I'm gonna be the one to  
7 do the poll.

8 MR. STOVAMOR: Define "relaxed."

9 MS. EVERGREEN: "Relaxed" as in, if someone says to me  
10 like, "are you a guy or a girl," I'll say "girl," say  
11 "she/her," but "relaxed" as in if I'm telling a story about  
12 myself as I was at the start of this trial, it wouldn't count.  
13 If I'm quoting myself, stuff like that.

14 I would say an obvious rule. I would say that would  
15 have been the rule to begin with but some of you disagree.

16 "Is not knowing that jury duty exists in the UK part  
17 of the bimbo performance? "Is that a thing? I mean, I assume  
18 it's a thing, but identifier never heard of anyone going to  
19 jury duty in the UK.

20 Oh my god. "Okay, but heels always during the whole  
21 stream." That wasn't part of the rules -- that wasn't part of  
22 the rules. Heels suck.

23 MR. STOVAMOR: To be honest I'm fine with that because  
24 there's zero chance of you sticking to the full thing.

25 MS. EVERGREEN: "I'm fine with it?" Okay, Stov said he's

1 fine with it.

2 Okay. I'm gonna do a poll -- okay. I'm gonna do it.

3 Okay. Wait, hold on. Because I'm gonna do something for it. I'm  
4 doing it. Mods, don't do it. All right.

5 All right. I'm gonna write you up a thing.

6 THE COURT REPORTER: I heard you needed a stenographer  
7 but I was out having lunch, Sadge.

8 MS. EVERGREEN: Hey, ChaSiu. Long time no see.

9 F. I'm so sorry. We did, actually. I needed -- we  
10 were in a court case.

11 Okay. I would say it'll be -- okay. Just as an FYI,  
12 it is -- one week -- oh my god, my B key broke. Okay.

13 Right. All right. Here is -- there. That's as big as  
14 I can make it. I'm starting the poll. Go. One week extra, for  
15 relaxed pronoun rules, and heels on at all times during  
16 streams. There. I will allow it to the jury to make that a deal  
17 or no deal.

18 "In exchange for what?" What do you mean? Oh -- what  
19 do you mean? An extra week.

20 MR. KEIWO: I vote for deal.

21 MS. EVERGREEN: John and Stov both vote for deal. So,  
22 restart, basically. I've added an extra two days to get relaxed  
23 pronoun rules.

24 "Bikini stream needed." That's a separate thing. That  
25 would have changed into none of this, but relaxed pronoun rules

1 and a bikini stream. I can do that as well.

2           Okay. I'll give you a second one, because 90 percent  
3 of you have voted deal for this one. Okay. Here's what I'll do  
4 -- let's see, I'm not -- I was not gonna do a bikini stream  
5 anyway. That was not in the cards. There is currently no plan  
6 on doing a bikini stream, at least not for a while. Not for  
7 fuckin -- a while.

8           Let's see. Okay.

9           MR. STOVAMOR: You said there was, but I guess that was  
10 a "misunderstanding."

11           MS. EVERGREEN: I mean, I am gonna do it at some point,  
12 just not during Girly Girl Month. Girly Girl Bimbo Month.

13           Okay. So, let me do another poll. Same format. I'm  
14 gonna only do it for one minute, because that was a while.

15           Okay. Everyone wanted a bikini stream, so here it is  
16 again. The bikini stream, for the John and bet -- the John and  
17 Stov bet -- the Jov and Stohn -- hold on, I spelled it wrong,  
18 sorry. "The Stohn and Jov bet carries on." Jov and Stohn. For a  
19 full bikini stream. String bikini stream. Think about that.  
20 Imagine the last bikini stream, Chat. Remember what the last --  
21 last swimsuit stream was like? Think about this, but a bikini  
22 stream.

23           MR. STOVAMOR: What? The bet is still carrying on.

24           MS. EVERGREEN: No, Stov; this is instead of the last  
25 one. This is instead of the last one. It's either the first one

1 or this one.

2 MR. STOVAMOR: Oh, fuck no. First one.

3 MS. EVERGREEN: "Unless it's full send, it's not worth  
4 it." It would be.

5 "Which option is deal?" The one that says "deal?"  
6 What do you mean?

7 "Scam." Okay, fine. Fine, I'll do the fuckin -- I'll  
8 do the extra week. The bikini stream remains not happening. I'm  
9 keeping that one in the -- in the cards for me to future gamble  
10 with later. You guys didn't want a bikini stream, you wanted an  
11 extra week of this. That's what you wanted.

12 "John and Stov win." The bet carries on. Hmm.

13 "You'll lose anyway." Hmm.

14 "You're trying to bribe Chat to avoid your time?" No?  
15 Maybe. (Laughing) It's fine. This is fine. It's solid.

16 (Adjourned at 2 hours, 43 minutes.)
